



Contributor License Agreement

Kernkonzept GmbH

Thank you for your interest in the L4Re System. Kernkonzept GmbH, the maintainer of the L4Re operating system (including the L4Re Microkernel, AKA L4/Fiasco.OC; the L4Re Runtime Environment; and, L4Linux) ("L4Re System"), asks contributors who submit code or documentation to the L4Re System to clarify the intellectual property license under which they release their contributions to the system. Kernkonzept must have a Contributor License Agreement ("CLA") on file that has been signed by each contributor, indicating agreement to the license terms below.

This CLA is intended to protect both contributors and Kernkonzept, by ensuring three important objectives: First, contributors retain their original copyright. Second, Kernkonzept can make contributions available under an open-source license; typically, the open-source license under which the contributor originally obtained the component for which the contribution is intended. And third, Kernkonzept retains its ability to use and license the L4Re System in any way it sees fit, including for commercial licensing.

The CLA can be used to submit original contributions (unencumbered by third-party licenses) intended for integration into the L4Re System. (Kernkonzept also welcomes submissions of work derived from third-party open-source code, but they typically cannot be licensed under this CLA. It is sufficient to make these submissions available to Kernkonzept under the original third-party open-source license.)

In order to be subject to the terms of this CLA, Contributions need to be clearly marked as a "Contribution covered by the CLA" and need to be sent from (one of) the e-mail address(es) given above. Contributions can be submitted via e-mail to info@kernkonzept.com or to a person identified by Kernkonzept. Additionally, Kernkonzept may offer other interfaces for submitting and marking Contributions, such as a web-based code-review system.

Except for the license granted herein to Kernkonzept and recipients of software distributed by Kernkonzept, the Contributor retains all rights, title, and interest in and to the Contribution.

2 Grant of copyright license

The Contributor hereby grants Kernkonzept a non-exclusive, but otherwise unlimited, perpetual, worldwide, no-charge, royalty-free, irrevocable copyright license to use, reproduce, sublicense, prepare derivative works of, publicly perform and display, and distribute the Contribution(s) and such derivative works, in any way that Kernkonzept may see fit. This license includes, but is not limited to, the right to sublicense the Contribution(s), or derivative works thereof, under any open-source or commercial license, and to use the Contribution(s), or derivative works thereof, for commercial purposes, subject to the terms and conditions of this CLA.

3 Grant of patent license

The Contributor hereby grants Kernkonzept and recipients of software distributed by Kernkonzept that incorporates the Contribution(s) a non-exclusive, but otherwise unlimited, perpetual, worldwide, no-charge, royalty-free, irrevocable (except as stated in this section) patent license to make, have made, use, offer to sell, sell, import, and otherwise transfer the Contribution(s) and the L4Re System, where such license applies only to those patent claims licensable at no cost by the Contributor that are necessarily infringed by the Contribution(s) alone or by combination of the Contribution(s) with the L4Re System. If any entity institutes patent litigation against the Contributor or any other entity (including a cross-claim or counterclaim in a lawsuit) alleging that a Contribution, or the L4Re System, constitutes direct or contributory patent infringement, then any patent licenses granted to that entity under this CLA for that Contribution or the L4Re System shall terminate as of the date such litigation is filed.

4 Incorporation of Contribution

The Contributor acknowledges that Kernkonzept is under no obligation to incorporate the Contribution(s) into software distributed by Kernkonzept.

6 Personal data protection

The Contributor acknowledges that Kernkonzept stores, processes, and may disclose to third parties, personal data of the Contributor, as given in Section 1, but only for the purposes of identifying or acknowledging Contributions made by the Contributor; exercising the rights granted in this CLA; or, complying with any legislation or court order that requires Kernkonzept to store, process, or disclose said personal data.
